會員資格

起點會員

所有15-29歲可在香港合法受僱及居住的青年人,在完成登記手續後,即成爲Y.E.S.的 起點會員。會籍有效期爲一年。除爲商務會員而設的服務及設施外,起點會員可使用 Y.E.S.內所有其他服務及設施。

商務會員

所有 18-29 歲的起點會員,凡經營自僱業務並領有商業登記證(不論是以獨資經營者、 合夥人或公司董事名義),均可申請成為商務會員,使用專為商務會員而設的服務及設施,包括:商務工作間、商務會議室、專業設計基地及專業諮詢服務等。

◆ 核實商業登記證

起點會員需要在申請成爲商務會員時,出示有效的商業登記證及填寫「商務會員承諾書」。職員會透過香港特別行政區政府網站,核實商業登記上的資料,並將該會員的商業登記證副本存檔。

➡ 臨時商務會員的注意事項

- ▶ 未領有商業登記證的起點會員無論正在經營或開始計劃經營自僱業務,均可申 請成爲臨時商務會員。
- ▶ 臨時商務會員可使用商務會員的服務及設施,但不包括 Y.E.S. 免費提供的專業顧問諮詢服務。
- 臨時商務會員會籍爲期半年,每位合資格人士只有一次獲批成爲臨時商務會員的機會。

續會事官

- ➤ Y.E.S.亦會爲其商業登記證仍生效的 18-29 歲商務會員自動續會一年。但若其 遞交的商業登記證已過期,商務會員必須再向 Y.E.S.出示有效商業登記證;否 則,其會籍將自動轉回起點會員。

续会事宜

所有起点会员及商务会员的会籍有效期为一年。会籍到期时:

- ▶ 一般情况下, Y.E.S. 会为所有 15-29 岁的起点会员自动续会一年。
- ➤ Y.E.S.亦会为其商业登记证仍生效的 18-29 岁商务会员自动续会一年。但若其 递交的商业登记证已过期,商务会员必须再向 Y.E.S.出示有效商业登记证; 否则,其会籍将自动转回起点会员。

Eligibility of Membership

Y.E.S. members

All young people aged between 15 and 29 who legally reside and work in Hong Kong and have completed the registration formalities will become Y.E.S. members. The membership is valid over a period of one year. Except for the services and facilities which are exclusively dedicated to business members, Y.E.S. members are eligible to use all Y.E.S. services and facilities.

Business members

All Y.E.S. members aged between 18 and 29 who run their self-employed businesses and possess a business registration certificate (regardless in the capacity of a sole proprietor / partner / director) may apply to become business members, who are eligible to use the services and facilities that are exclusively dedicated to them. These include business workstations, business room, professional design corner and professional consultation services etc.

• Verification of business registration certificates

Y.E.S. members are required to produce a valid business registration certificate and complete an "Undertaking of Business Member" when applying for business membership. Staff members will verify the information contained in the certificate by making use of the website of the Hong Kong Special Administrative Region Government and keep a copy of the certificate for record.

- Points to note for provisional business members
 - Y.E.S. members who are running or interested in establishing their self-employed businesses but have not yet acquired a business registration certificate may first register as provisional business members.
 - Provisional business members can use the services and facilities intended for business members but they will not be provided with free professional consultation by Y.E.S.
 - ➤ The membership of provisional business member is valid over a period of half a year, but every qualified member only have one chance for registering as provisional business member.
 - Provisional business members will have to acquire a business registration certificate within 6 months from the date of registration in order to complete the registration procedures for becoming a business member. Should a provisional business member be unable to produce a valid business registration certificate within the six-month period subsequent to his/her obtainment of provisional business membership, this membership shall be automatically changed to Y.E.S. membership.

Membership renewal

Both the Y.E.S. membership and the business membership are valid over a period of one year. When their original membership expires:

Under normal circumstances, all Y.E.S members aged between 15 and 29 will be automatically granted a renewed membership.

Membership of Y.E.S Business members will be automatically granted a one-year renewal if the business registration certificate previously produced by them is still valid. Should the certificate have expired, business members must produce their valid business registration certificates again for inspection by Y.E.S. Otherwise, membership of business members will be automatically changed to Y.E.S. membership.
